### **ELIGIBILITY CRITERIA**

- Period of existence and operations should not exceed 10 years 01 from the Date of Incorporation.
- Firm must be Incorporated as a Private Limited Company, a 02 Registered Partnership Firm or a Limited Liability Partnership.
- Should have an annual turnover not exceeding Rs. 100 crore 03 for any of the financial years since Incorporation.
- Entity should not have been formed by splitting up or 04 reconstructing an existing business.

### **DOCUMENTS REQUIRED**







#### Q1. Can a foreign company register under Startup India hub?

**Ans.** Any entity having at least one registered office in India is welcome to register on the hub as location preferences, for the time being, are only created for Indian states. However, we are working on international relations and will soon be able to enable registration for stakeholders from the global ecosystem

### Q2. Would a One Person Company (OPC) be eligible to avail benefits under the Startup India initiative?

Ans. Yes. One Person Companies are eligible to avail benefits under the Startup India initiative.

#### Q3. Can a foreigner enter into a partnership under the LLP Act and get that LLP registered with Startup India?

**Ans.** Yes, a foreign national can enter into a partnership under the LLP Act and get that LLP registered on our website. It can even get recognized by the DIPP.

#### Q4. Can I provide two mobile numbers in the registration form?

Ans. Only one mobile number and one landline number of the authorized representative of the entity can be provided at the time of registration. The portal and the mobile app would be sending an OTP on the mobile number provided by the user to complete the authentication and registration process.
